This Policy therefore governs the privacy of its users who choose to use them. The policy sets out the different areas where user privacy is concerned and outlines the obligations & requirements of the users, the websites and website owners.

The Website(s)

Our websites and our owners take a proactive approach to user privacy and ensure the necessary steps are taken to protect the privacy of its users throughout their visiting experience.

Use of Cookies

Some of our websites use google tracking software to monitor visitors (anonymously) and to better understand how these visitors use our sites. This software is provided by Google Analytics which uses cookies to track visitor usage. The software will save a cookie to your computers hard drive in order to track and monitor your engagement and usage of the website, but will not store, save or collect personal information.

Other cookies may be stored to your computers hard drive by external vendors when our websites use referral programs, sponsored links or adverts. Such cookies are used for conversion and referral tracking and typically expire after 30 days, though some may take longer. No personal information is stored, saved or collected.

Contact & Communication

Users contacting our websites or their owners do so at their own discretion and provide any such personal details requested at their own risk. Your personal information is kept private and stored securely until a time it is no longer required or has no use.

Every effort has been made to ensure a safe and secure form to email submission process, but advise users using such forms to email processes that they do so at their own risk.

Our website owners use any information submitted to provide you with further information about the products/services/latest news that we offer, or to assist you in answering any questions or queries you may have submitted.

This includes using your details to subscribe you to any email newsletter program the website(s) operate, but only if this was made clear to you and your express permission was granted when submitting any form to *email process**. Your details are not passed on to any third parties.

**The exception to this procedure is a follow up email to an original email enquiry in the form of a newsletter, which you are free to unsubscribe from.*

Email Newsletter

Some of our websites operate an email newsletter program, used to inform subscribers about products/services/news supplied by us. Users can subscribe through an online automated process should they wish to do so, but do so at their own discretion. Some subscriptions may be manually processed through prior *written agreement with the user**.

**The exception to this procedure is a follow up email to an original email enquiry in the form of a newsletter, which you are free to unsubscribe from. Most users are students of the clubs run by ACS MAGFA and have supplied their emails as part of the registration process.*

Subscriptions are taken in compliance with UK Spam Laws. All personal details relating to subscriptions are held securely and in accordance with the Data Protection. No personal details are passed on to third parties or shared with companies or people outside of the company that operates our websites.

Under the Data Protection Act you may request a copy of personal information held about you by our website's email newsletter program. A small admin fee maybe required. If you would like a copy of the information held on you please write to the business address at the bottom of this policy.

Email marketing campaigns published by our websites or our owners may contain tracking facilities within the actual email. Subscriber activity is tracked and stored in a database for future analysis and evaluation. Such tracked activity may include; the opening of emails, forwarding of emails, the clicking of links within the email content, times, dates and frequency of activity (this is by no far a comprehensive list).

This information is used to refine future email campaigns and supply the user with more relevant content based around their activity.

In compliance with UK Spam Laws and the Privacy and Electronic Communications Regulations subscribers are given the opportunity to un-subscribe at any time through an automated system. This process is detailed at the footer of each email campaign.

If an automated un-subscription system is unavailable clear instructions on how to un-subscribe will be detailed instead.

External Links

Although our websites only look to include quality, safe and relevant external links, users are advised to adopt a policy of caution before clicking any external web links

mentioned throughout our websites. (External links are clickable text/banner/image links to other websites.)

The owners of our websites cannot guarantee or verify the contents of any externally linked website despite our best efforts. Adverts and Sponsored Links
